

Admission Policies

ADMISSION

The goal of the Admissions Board is to select students who show intellectual capacity, demonstrate leadership ability and possess personal characteristics that best equip them for careers in HR.

ENROLLMENT

Applications received from the students are checked for the basic eligibility criteria and the eligible students are enrolled into the program. The applications received from students awaiting final year results or those who do not have the certificates readily for submission, will also be processed and enrolled into the program. However, s uch students will have to submit the relevant certificates of the qualifications claimed in the application as soon as they are made available to such students .

REJECTED APPLICATIONS

If the applicants do not satisfy the eligibility criteria, the applications are returned to them along with all enclosures and the payment paid after deducting Rs.500 as processing fee.. Such students are, however, permitted to apply again after they satisfy the eligibility criteria. The students whose applications have been rejected may appeal to the Admissions Board, if they wish to have a review of their applications.

PAYMENT

The applicants are required to pay the basic fee for each of the PG Diploma Program as notified

NO REFUND

The amount once paid is not refundable under any circ umstance, except in the case of rejected applications.
